The Trans Health and Law conference goal is for participants to leave with a better understanding of the issues facing Transgender and gender non-conforming individuals in the area of

Last year's conference had over 170 attendees from the professional health and social services fields, students and members of the trans-community.

There were 28 workshops given over the course of the day (each workshop is 1 hour long and there are 4 time slots with 7 workshops per slot).
